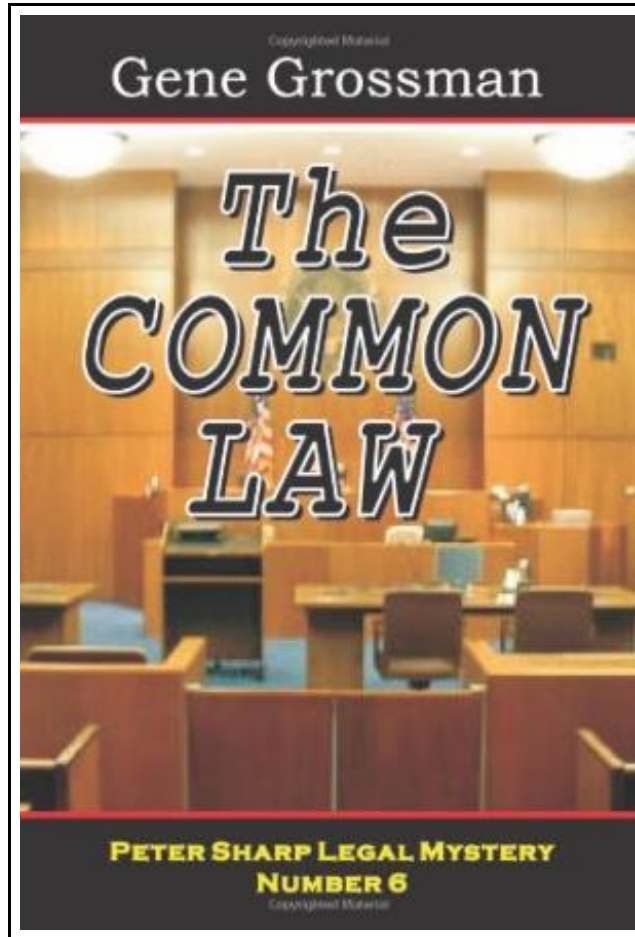

In lieu of his memory, Peter obtains video surveillance footage that unfortunately establishes his clients guilt beyond a reasonable doubt. Peters other new experience is that of an instructor. An old classmate of his now conducts seminars on preparation for the California State Bars first-year law students examination, and has asked Peter to come in as a guest lecturer. One of the students there becomes an asset on a particular case. As in past adventures, Peters usual crew also gets involved, including his close friend Stuart, Jack Bibberman the investigator, Laverne the amorous houseboat lady, and Stuarts employees Vinnie and Olive who are having some disagreement as to whether or not theyre legally married - and last but not least little Suzi B. and her big Saint Bernard.
